UNDERGRADUATE SUMMER RESEARCH FELLOWSHIP: R_xCOGNIZING RESEARCH POTENTIAL

Program Goals:

The R_xcognizing Research Potential: Undergraduate Summer Research Fellowships are designed to introduce undergraduate nursing students to scientific research and nurture research potential. The Fellowship also acts to highlight the College of Nursing research signature areas and guide students through the practical processes required for conducting research.

The Fellowships will support the full-time salary for a student working under a faculty member at the College of Nursing. The students will work in conjunction with The Nursing Unit for Research and Scholarship Excellent (NURSE) for research support purposes. The intent of these awards is to build student research skills and provide valuable research experience, inspiring students to consider pursuing graduate studies and continued research efforts.

Timeline:

- **January 9, 2024:** Funding announcement; Release of Application Document
- **February 28, 2024:** Application deadline
- **March 25, 2024:** Notification of awards
- **April 15, 2024:** deadline to submit REB by supervisor (where required)
- **July 1, 2024:** Project start date

Number of Applications:

Only one submission per applicant will be considered. Thus, each student and each supervisor may only submit one application per year. Each project submitted is to be a stand-alone project with clearly defined objectives and outcomes.

Eligibility:

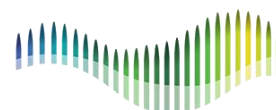
This program is available to all College of Nursing undergraduate students at the University of Saskatchewan (all campuses). Students are invited to apply and those accepted into the R_x Fellowship must confirm that they are currently registered students and must have a **minimum average of 80% in their last two terms.**

Supervisors must be faculty who are **eligible to hold research funds** in the College for the duration of the award period. Any questions regarding eligibility should be directed to nursing.research@usask.ca at least one week before the deadline so that we are able to assist you with assessing your eligibility.

Faculty and students must commit to the fellowship requirements, described below. The project must be feasible for the timeline provided and appropriate for an introductory researcher level.

Length and Number of Awards:

Research projects are eight (8) weeks and run from July 1 – August 31, 2024. There will be a maximum of four (4) awards granted per year, representing one project from each of the three [Signature Area](#) and one additional fellowship for a equity deserving group. Equity deserving groups include persons with disabilities, those of Indigenous ancestry, visible minorities and/or women, members of the LGBTQ2IA+ community, or any other identified equity deserving group. This is a salary award is awarded students will be hired as term employees. Students will receive \$15/hr and will work 37.5 hours a week. Vacation days must be coordinated in advance with the supervisors and taken within the project term as these will not be paid out from the award at the end of the work term. Supervisors will need to provide a fund number to cover any additional expenses incurred beyond the value of award, such as vacation pay.

Choosing and Submitting a Project

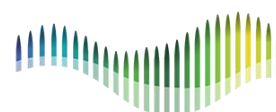
Students who have an idea for a project or an interest in a particular area are encouraged to approach faculty with their ideas. The see faculty research areas view our College of Nursing [Research and Scholarship Snapshot](#) Booklet. Once student and faculty members are paired, they can begin completing an application to submit together. Examples of appropriate projects may include: concept development, developing questionnaire/interview guides, testing measurement tools, practicing interview and other qualitative methods, exposure to literature review or data analysis, secondary data analysis.

Application

Submit a complete application form to nursing.research@usask.ca by 5:00PM on February 28, 2024.

Assessment

Write your application in a manner that can be understood by a non-expert. Applications will be assessed and ranked by the Associate Dean Research and Graduate Studies and NURSE using the evaluation rubric. The grading rubric will include assessment measures such as (1) student academic standing (2) project feasibility (3) strength of the application.



Notice of Decision Written notification of the outcome of applications will be sent to applicants by March 25th, 2024. Successful applicants will have two weeks to submit written notification of award acceptance to nursing.research@usask.ca and return the required hiring documents. Any projects requiring REB approval will require that they application be submitted no later than April 15th.

All projects will be embargoed until a standard release time in late April.

Supervisor and Student Responsibilities

Students

- Award is considered full-time employment and students may not hold other employment for duration of the award.
- Must work the allotted weeks at 37.5 hours/week. Notify the supervisor if this is not possible.
- The student commits to respond promptly to all communication with their supervisor and NURSE (expectation of 48 hours or less between Monday - Friday)
- Complete the mid-way and final report on Survey Monkey.
- Present your research at the College of Nursing Research and Scholarship Day

Supervisors

- Must obtain ethics approval if required. REB applications must be submitted by April 15 to allow for the approval process to take place before the project start date.
- Complete the mid-way and final report on Survey Monkey.
- Mentor and supervise the student.
- A commitment to work in conjunction with NURSE to achieve the project goals and attend Rx-specific workshops/events
- Report promptly to interdisciplinary.research@usask.ca if the student does not meet the funding requirements of the program.

Supervisor Expectations

It is expected that if a proposed project has any impact on a third party, that the supervisor is to inform the third party of any implications and obtain written permission to continue with the research. Failure to comply with this could result in the cancellation of an awarded project.

Reporting Requirements

Reports

All recipients will submit a mid-point and final report via SurveyMonkey. Mid-point and final reports will be used to assess progress, timelines and other concerns.

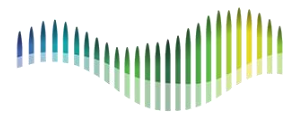

Students may also wish to participate in the SURE symposium in late summer or fall or Life and Health Sciences Expo in May but this cannot be a substitute for the CoN Research and Scholarship Day presentation unless approved by your supervisor and NURSE. Details regarding the location and time of these research days will be sent out in the summer.

COMPLETED BY STUDENT: OPTIONAL. Is there anything else that you would like our adjudicators to know to help them to evaluate your academic performance? This could include explaining any challenges that you have faced or explanations for lower grades. It could also include a statement about equity considerations or letting us know about your successes, such as maintaining an excellent average while having extra responsibilities such as work or volunteering. This question can help our adjudicators to understand your academic story and can be factored into their evaluation of your academic excellence.
